- All objects/items must be moved under and surrounding trees and felling zones that will need work performed. This includes tables, chairs, wind chimes, bird feeders, bird baths, pots, planters, umbrellas, drain spouts on ground, grills
- Any dog waste must be cleaned up prior to our arrival or a cost will be incurred to you for clean up
- We ask that you please have your lawn mowed if possible a day or two before our arrival so we can clean up your property as best as possible. High grass is much more difficult to do the final clean up in.
- If you need the driveway accessible during our service we need to be informed prior to the start of the job. Sometimes our driver may be up in the tree and could not move the truck at a moments notice.
- Please make us aware of any new construction that is being done that will affect the tree services that will be performed. Ie, new fence, deck, driveway, addition, patios, landscaping and any other new additions to the work area.
